Certificate of Eligibility for Nonimmigrant (O-1) Visa: An alien may be eligible to receive a nonimmigrant visa in the United States if he or she meets the requirements for nonimmigrant (O) classification. An applicant must have at least one of the following criteria. If two or more of these apply, the alien must satisfy all applicable requirements to be certified as eligible: 1. Has a significant public profile or has exhibited exceptional creative or scholarly achievement 2. Has made an extraordinary contribution to the field of world-renowned scholars or experts in his or her area of specialty 3. Has a record of extraordinary contributions to the field of the arts 4. Is a person of extraordinary ability. To qualify as a person of extraordinary ability, an alien must demonstrate high levels of expertise in the fields of science, the arts, or education, as evidenced by consistently high critical acclaim and achievement. The alien must also be an outstanding leader in his or her field. As used for this purpose, leadership is recognized as the ability to influence or direct the activities of others, to achieve consensus, to direct others, to inspire and direct effort, to provide spiritual guidance, or to provide a sense of common purpose, direction, or mission. The alien must be recognized nationally or internationally in his or her field. It is not sufficient to be highly respected or commonly known among one's field peers. Applicants for O-1 visa must obtain a recommendation from a professor or instructor at a U.S. institution of higher education. An alien is presumed to have not made an extraordinary contribution to the field of a renowned scholar or expert in his or her area of specialty if the alien does not show that he or she has made a significant contribution to a recognized field within his or her area of specialization. Additionally, an alien must be able to show a record of superior and exceptional ability. An alien is presumed not to have this record if the alien does not show that he or she has consistently exhibited high levels of critical acclaim and achievement in his or her field and/or has made significant contributions. An alien will also be presumed not to have an extraordinary ability if the alien does not show that he or she has achieved distinction in his or her field at an advanced level that is comparable to the performance of individuals who have made extraordinary contributions to the field, either in their own right or because of their leadership. An alien will be presumed not to have a record of superior and exceptional achievement if the alien does not show that he or she has consistently exhibited high levels of critical acclaim and achievement in his or her field.

Recovery of Approved Leave: An I-797 form, commonly called a "Notice of Action," gives a non-immigrant visa holder permission to remain in the U.S. for a specific length of time. To apply for a "Recovery of Approved Leave," you need to request an extension of your approved period of stay (the authorized date) at an immigration office in the U.S. You may request an extension of your authorized date for any approved period of stay (the approved date) up to 1 year, even for periods longer than one year. You must apply for an extension before your authorized date has expired. After the authorized date has passed, you cannot apply for a new extension. With few exceptions, an approved leave of stay can be extended for up to 1 year. An approved leave of stay can be extended in any case at the option of the alien, whenever the alien may wish to remain in the U.S. for a longer period of time. The alien may apply for an extension of his or her authorized date for any approved period of stay (the approved date) up to 1 year, even for periods longer than one year.
